WORK SESSION

CTE & Gifted Programs Presentation

Brad Callender, Director of Career & Technical Education, presented an update to the Board on Career and Technical Education and how our CTE program aligns with the District Strategic Plan. Robert Swaggard, Director of Curriculum and Instruction, and Jeff Porter, Automotive Instructor, provided input on the presentation. The Tri-Heights Consortium consists of fourteen programs among three high schools: Cleveland Heights, Shaker Heights, and Warrensville Heights. Mr. Callender pointed out that the CTE plan not only aligns with the District Strategic Plan but with State of Ohio compliance requirements. The District Mission Statement supports the fact that career readiness and success is just as important as college readiness and success for our students.

Toia Robinson, Coordinator of Gifted & Fine Arts, presented an update to the Board on programming options for gifted and fine arts students in the District. She also presented information from Hanover Research, a firm used to conduct a study on our current gifted program model. Hanover Research provided the District with a summary of best practices and recommended next steps for gifted education in the mainstream classroom that align with our Strategic Plan. Ms. Robinson shared that our gifted program focuses on the "whole" child (including social and emotional functions); not just academics. It is designed to help students think critically and creatively and to function with 21st century skills. Our current gifted program model is being reviewed and will be improved so that we can provide an excellent education for all our students.
