## WORK SESSION

## **Educational Services Presentation: Special Education Programs**

Dr. Jeffrey Johnston, Director of Student Services, provided the Board with an update on the Special Education program goals and items of focus for the 2016-2017 school year. Dr. Johnston discussed how the program aligns with the District's strategic plan. The Student Services Department focuses on both the academic and social-emotional needs of all students in our District. The students receiving special education in our District range from 16%-18% of our total student body. Dr. Johnston explained the difference between special education laws versus 504 plan laws. There is no funding for Section 504, and this is becoming a significant need among our student population.

As the District graduation rate increased, so did the graduation rate for students with special needs. In order to close the achievement gap and meet the Value Added indicator on the local report card, Student Services plans to focus on increasing teacher and student access to core curriculum and on supporting general and special education teachers with inclusion strategies. Dr. Johnston pointed out that in order to increase student success the Department has expanded community work experience opportunities for students with special needs along with adding Career Based Intervention (CBI) courses at the High School specifically for these students.

Dr. Johnston discussed fiscal resources available for students with special needs and how these resources impact our District. He anticipates that the number of students eligible for Jon Peterson scholarships will continue to increase, which means staff time to create and support IEPs for non-public students will also increase.

Lisa Hunt and Amy Kerr-Jung, Reaching Heights Exceptional Children's Advocacy Group (ECAG), spoke about parent and community engagement related to special needs services in the District.

In conclusion, Dr. Johnston commented that he is proud of the commitment our staff makes to serve students. He also thanked Superintendent Dixon and the Educational Services team for creating a positive environment that understands the needs of students and staff in the District.
