AUTHORIZATION FOR THE CHIEF FINANCIAL OFFICER OF THE BOARD, TO HAVE SIGNED BY AN ATTORNEY, COMPLAINTS AS TO THE ASSESSMENT OF REAL PROPERTY IN THE DISTRICT

WHEREAS, it is necessary to the efficient operation of the Cleveland Heights-University Heights City School District ("District") that the Board of Education of the District ("Board") file complaints as to the assessment of real property located in the District when it appears that the fair market value of real property located in the District is greater than that indicated by its current taxable value;

NOW, THEREFORE, BE IT RESOLVED by the Board that the Chief Financial Officer of the Board, is specifically authorized by the Board, to have signed by an attorney on behalf of the Board all pleadings, complaints, or other papers pertinent to any proceedings involving the valuation of real property located in the District.

FIDELITY BONDS

AWARDS/RECOGNITIONS

CTE Program of the Month – Auto Tech

Dr. Talisa Dixon, Superintendent, recognized the Automotive Technology program. Program Instructor Jeff Porter and student **Dylan Kuntz** shared some of the program's features. Mr. Porter said the new facility at Delisle Options Center is high tech and state of the art. Students in the program are using state-of-the-art tools, equipment and cutting-edge technology as professional mechanics to identify mechanical or electrical problems, maintain, and repair all automotive systems. During the 2014-2015 school year, the program and the facility received accreditation from the National Institute for Automotive Service Excellence (ASE). This means that students are eligible to earn the G1 High School Auto Technology certification. Heights students who earn the certification often go on to enroll in auto technology programs at the college level, and can potentially earn \$50-70,000 a year when entering the workforce thereafter. **Dylan** expressed how beneficial the program is and said that he is already working part time in the industry.
