**Cleveland Heights High School – Security Update**

Bryan Loretz, Coordinator of Safety & Security, provided the Board with an update on improving security measures at the High School. The District has been working closely with local police departments to study best practices to ensure we provide a safe, secure, and drug-free environment for students. One effective measure used by several of our peer districts is periodic walkthroughs by police with drug-detecting dogs. The District will begin using this security measure on a random basis.
