### **Context Of Our Work**

- The draft reopening plan is guided by the core values of safety, equity, collaboration, academic excellence, responsibility, and student success.
- The five goals of our strategic plan remain our guide.
- The draft reopening plan aligns with the Reset and Restart Education <u>Planning Guide</u> released by the State of Ohio on July 2, 2020. The draft plan was also informed by surveys of families and staff.


## **Educational Services**

Goal - Provide a high quality education to all of our students in grades Pre-K through 12 in the 2020-2021 school year.




In June, the District distributed a fall planning survey to families via email, social media, and telephone calls, ultimately receiving 2,041 responses (approximately <sup>2</sup>/<sub>3</sub> of District families).

We asked: Are you in favor of starting the school year on September 2 in order to give teachers time to plan and prepare for the opening of school?






We asked: What measures do you think are most important to maintain safety in our schools with regard to COVID-19? (Check all that apply)






We then asked questions regarding each child.

We asked: If it is determined safe to return to school in the fall, how comfortable are you sending your student to school? (Scale of 1–5; 1 is not comfortable at all, 5 is completely comfortable).






We asked: If we were required to do a blended model of instruction due to health concerns and restrictions, which model of instruction would you prefer?





We asked: If you are not open to either an in-person or a blended learning model this fall, are you interested in having your child participate in a fully online program for the 20–21 school year?





#### **Educational Implications - Felisha Gould**

In summary...

**Nearly 37**% are not comfortable returning to in person learning this fall. **Approximately 63**% responded either "moderately comfortable" or "completely comfortable".

A total of **81**% are in favor of starting the school year on September 2.

Approximately **30-60**% are interested in online learning, depending on the model offered.

Parents highly value the regular disinfection of classrooms and breaks for handwashing and sanitizing in keeping schools safe.



#### Instructional Model 1 - Blended

**Blended Learning:** This learning model combines in-person instruction with an element of learning that takes place when students are away from the school setting. This model reduces the number of students in each school building and classroom, to better accommodate CDC guidelines for social distancing.

Project-based learning

#### **Operations**

- Oxford Preschool temporarily closed for 20-21 school year due to low enrollment.
- 9 students per room (5 students with special needs:4 peers) a true inclusion model.
- Monday-Friday AM 8:30-11:00 & PM 12:30-3:00- hours change slightly, Wednesdays are teachers' planning time and meetings.

#### Health & Safety

Shortening the sessions by a half hour each gives staff 1 hour between sessions to sanitize toys, change PPE, and prepare materials needed for instruction for the next session.

Ohio Learning Standards and the four learning domains

#### **Operations**

- □ Students in grades K-12 will attend school in a Blended Model
- □ Students in **Group A with last names A-K** and **Group B with last names L-Z**
- □ Virtual Wednesday (support for students who need additional assistance, cleaning, video lessons, and meetings–Staff, BLT, IEP, TAP, TBT, SAT)
- **EXCEPTION**-Students receiving Special Education services in an **intensive classroom setting (self-contained)** will attend classes five days a week; Multiple Disabilities (**MD**), Emotional Disturbance (**ED**), and Autism (**AU**)

#### Health & Safety

- A Day and B Day schedule allow for social distancing measures to be followed.
- □ Students in grades K-12 will be required to wear face masks.
- □ Employees will wear face coverings that allow for instruction.
- Handwashing and regular cleaning protocols will be implemented.



## Instructional Model 2 - Virtual Alternative

#### mySchool Online

This model is designed for students and families who would like to maintain their connection to CH-UH teachers, but don't yet feel comfortable sending their student(s) back to a traditional school building this coming fall.

With mySchool Online, students will attend school remotely, following the standard school schedule and bell times. This learning model will incorporate many of the features that parents and students valued most about instruction this past spring, such as regular virtual real-time interaction with teachers every day for every class.



## Instructional Model 3 - Virtual Alternative

#### **Full Online School**

This full-time virtual school experience is ideal for students who wish to have more control over their learning path and pace, and for whom a flexible daily schedule is important.

In this learning model, students often work on assignments during non-traditional hours and maintain contact with a certified teacher and classmates using web-based class sessions, email, text messages, and phone calls. This option is available for students in Kindergarten through 12th grade through a fully online curriculum.



## Instructional Model 4 - Fully In-Person

We are currently exploring plans to offer K-5 instruction for five days per week for interested parents.

In order to fully understand the feasibility of this option, we are investigating available square footage at each building, room & space utilization, and available personnel.



## Instructional Model Selection Process & Timeline

**Process for registration & timeline for virtual alternatives** 

- Notice of CH-UH options for re-opening July 9
- Collect transportation (for eligible families) information July 17
- Student/Family registration for virtual alternatives July 9-24
- Plan staffing model based on family registration July 24 August
   12
- Students enrolled by **Aug 14** (given teacher assignments, virtual set-up)



# Human Resources and Operations

Goal - Ensure we have the human, operational and fiscal resources and supports to provide a high quality education to all of our students in grades PreK - 12 in the 2020-2021 school year.




In June, the District distributed a fall planning survey to staff via email ultimately receiving 532 responses (approximately half of District staff). The majority (69.2%) of respondents were certified staff who work in school buildings.





We asked: Are you in favor of starting the school year on September 2 in order to give teachers time to plan and prepare for the opening of school?


The majority (83.2%) answered "Yes," while 4.3% said "No" and 12.5% had no preference.






We asked: Assuming there will be health and safety precautions in place in line with state and federal guidance, how comfortable are you with the idea of returning to school/work in-person?

Nearly 30% of respondents said they feel somewhere in the middle with a "3" rating. Meanwhile, 21.5% said they do not feel comfortable at all, and 9.2% said they feel completely comfortable.

## **School Climate - Paul Lombardo**

Goal: Provide a safe and secure school climate aligned to national guidelines on how operate schools and school systems during a pandemic.

#### Tiger Nation Workplace/Building Protocols

- ❖ Face Coverings (K-12)
  - Create Face Covering Policy (BOE) per Ohio's Reset and Restart Education Planning Guide
  - > Students required to bring their own
  - Staff will be given face shields
- Conduct Daily Health Self-Assessment By Employees/Students
  - COVID-19 Symptoms: fever or chills/cough/shortness of breath/fatigue/muscle or body aches/loss of taste or smell/headache/sore throat/congestion runny nose/nausea or vomiting/diarrhea
- Wash and Sanitize Hands Frequently To Prevent Spread
  - Hand sanitizer/soap will be available in classrooms and all occupied spaces/hand washing breaks
- Practice Social Distancing (6 feet apart)



## **School Climate - Paul Lombardo**

Goal: Provide a safe and secure school climate aligned to national guidelines on how operate schools and school systems during a pandemic.

#### Tiger Nation Workplace/Building Protocols

- Employees and Guests
  - Practice Social Distancing (minimum 6 feet apart)
  - > Face Coverings **Required**
  - Visitors/Volunteers Limited Access
- Physical Space/Workstations
  - > Frequent Disinfection
- Confirmed Cases
  - Immediate Isolation/Quarantine (CDC Guidelines)/Call County Health/ Disinfect/Seek Medical Care
- Trainings
  - > In person ℰ Videos



## **School Climate - Paul Lombardo**

Goal: Provide a safe and secure school climate aligned to national guidelines on how operate schools and school systems during a pandemic.

#### CDC Guidelines for Quarantine

- Anyone who has been in close contact with someone who has COVID-19.
- What counts as close contact?
  - You were within 6 feet of someone who has COVID-19 for at least 15 minutes
  - You provided care at home to someone who is sick with COVID-19
  - You had direct physical contact with the person
  - You shared eating or drinking utensils
  - They sneezed, coughed, or somehow got respiratory droplets on you
- Steps to take
  - Stay home and monitor your health/14 days/stay away from high risk people



#### **Human Resources - Paul Lombardo**

Goal: Address staff coverage and employee COVID-19 related concerns.

- Substitutes
  - Recruit, Retain, Engage
  - Recruitment Days (2 in July/2 in August)
- COVID-19 Accommodations
  - Learn/Address Employee COVID-19 Related Concerns
  - Accommodation Procedures
    - HR Department carefully reviews all such requests, consulting with the employee, the employee's physician, and supervisors.



## Technology - Paul Lombardo

Goal: Eliminate barriers for student success, while advancing digital equity in CH-UH.

- Lead: Dr. Christy Bauer, Coordinator of Technology
  - > Provide 1 Chromebook for every K-12 student. Touchscreen Chromebooks are on order for K & 1 students.
  - Provide additional WiFi hotspots (pending eRate funding) for households as needs are identified through the back-to-school online forms.
  - Provide cases (on order) so students can safely transport Chromebooks between school and home as needed.
  - > Build out learning management system to support mySchool online virtual option.
    - Currently using Google (integrated gradebook, Infinite Campus connects with attendance)



## Cleaning & Safety - George Petkac

Goal: Ensure we develop and implement operational protocols in the areas of facilities, food service and transportation aligned to operating schools during a pandemic.

#### Ensuring Cleanliness

- Schools are cleaned and disinfected daily utilizing the Building Standards.
- > Inspections are conducted & documented twice daily by building Custodians.

#### Implementation of Cleaning and Sanitizing

- > Touch surfaces will be cleaned throughout the school day by the Custodial Staff.
- > Spray bottles with disinfectant & paper towels will be placed in each classroom for use by the teacher.



## Cleaning & Safety - George Petkac

#### Training

Nichols Paper & Supply Co. will be providing the District with virtual & in person refresher training for our cleaning staff on procedures for disinfecting our schools.

#### Procurement of Supplies

- All of the District's hand soap and hand sanitizer will be changed over to Purell for the start of the new school year.
- An inventory will be conducted of spaces that will need plexiglass separations for employees, and the devices will be ordered in July.
- Face shields for employees (1,100) will be made by Heights High engineering teacher Greg Nachman and paid for by the District.
- We currently have 7,000 face masks available which will be distributed to schools to issue to students who forgot or do not have a mask. We will be ordering child size face masks shortly.
- We currently have 13 no-touch thermometers that were purchased for the Custodial staff use. We will be ordering more for use at the schools.



## Food Service - George Petkac

Goal: Ensure we develop and implement operational protocols in the areas of facilities, food service and transportation aligned to operating schools during a pandemic.

- Lead: Anjali Rosedale, Food Service Resident Director
  - The recommendation for K-5 is that students eat breakfast & lunch in classrooms.
    - Breakfast can be served to students as they enter the school.
    - For lunch, students should come to the cafeteria maintaining social distancing, pick up a meal and return to their classroom to eat.
    - Investigating if K-2 can eat lunch in the cafeteria.
  - The recommendation for 6-12 is that students eat breakfast in the classrooms and lunch in the cafeteria.
    - Breakfast can be served to students as they enter the school.
    - Middle Schools will require more tables to be added in the cafeterias.
    - High School will need lunch periods added or shortened.
  - > Take Home Meals
    - Students not in school will be offered breakfast & lunch at their home school as a grab & go offer.



## Transportation - George Petkac

Goal: Ensure we develop and implement operational protocols in the areas of facilities, food service and transportation aligned to operating schools during a pandemic.

- Lead: Scott Smith, Supervisor of Transportation
  - > Surveying eligible parents regarding transportation use within the next week
  - > Investigating routes per proposed facilities plan
    - Students may have to be shuttled to and from schools early in order to maintain distance
  - Safety when riding the bus
    - All students riding the bus will be required to wear a mask
    - Parents/guardians should be checking students' temperatures before departing to bus stop along with washing hands
    - Parents/guardians/students will be responsible for maintaining proper distancing at bus stops
    - School loading and unloading will be completed in a timely, organized manner, keeping students as physically spaced as possible



## Transportation - George Petkac

#### Considerations

- May have difficulty supporting athletic trips due to social distancing of students on daily routes. Trips cannot interfere with daily to and from school routes per the Ohio Revised Code.
- Busing for non-public schools that are planning a full return for all students 5 days a week
- Additional costs; interior bus signage, hand sanitizer, additional cleaning supplies, time for cleaning
- County social distancing guidelines can affect bus routing, etc.



## Fiscal Considerations - Scott Gainer

- Dire current financial situation
  - Failed operating levy
  - Additional EdChoice losses
  - State funding cuts \$1.4 million annually
- ♦ \$9 million deficit 21-22 school year In Five-Year Forecast
  - Federal CARES relief already utilized to offset state funding cuts in 19-20 school year (no funds at this time to address additional costs)
- More information will be available based on family selection and transportation.



## Communications - Cathan Cavanaugh

Goal: Provide clear, consistent information regarding the reopening plan while providing opportunities for stakeholder feedback.
