# CH-UH City School District Reopening Plan Update


July 21, 2020

Level 1 Public Emergency: active exposure yellow and spread. Yellow Level 2 Public Emergency: Increased exposure and spread. Exercise high degree of caution. Orange exposure and spread. Limit activities as much as possible. Red much as possible. Level 4 Public Emergency: severe exposure and spread. Only leave home for purple supplies and services.

For All Public Emergency Levels, Follow All Current Health Orders

### LEVEL 1

Public Emergency Active exposure and spread.

#### LEVEL 2

Public Emergency Increased exposure and spread.

#### LEVEL 3

Public Emergency Very high exposure and spread.

### LEVEL 4

Public Emergency Severe exposure and spread.

The District will move to remote learning in the event of a Level 4 Public Emergency. The District will finalize appropriate models for Level 3, e.g. blended and remote learning only.

**In School Instruction:** All students attend school for core courses and electives. Students may be required to log in at designated times for certain electives and AP courses.

**Virtual Instruction:** Students taking classes online on the days they are not in school will participate in remote learning. On the remote learning day students are viewing classroom materials that may be recorded, access through a learning platform, or working with students who need additional assistance.

**mySchool Online**: All students attend school for core courses and electives <u>remotely</u>. Generally teachers assigned to MySchool online will work with students solely in the model. Students may be required to log in at designated times for certain electives and AP courses.



## Instructional Model 3 - Full Online

The **Ohio Online Learning Program** is a fully-virtual online program that school districts can purchase for their students in grades K-12 with courses that encourage excitement and creativity in the areas of math, science, reading, writing, social studies, world languages, wellness and visual arts.

Teachers: May or may not be CH-UH Teachers Course Offerings: Elementary = Lincoln Learning, Middle & High = Edgenuity Time: 5 days a week Electives: Provided through Ohio Online Learning

## FAQs Instructional Model 1 – Blended

### 1) What will the structure be for the three days at home?

For students who are participating in the blended learning, the three days at home will be spent working through assignments, engaging virtually with peers, viewing recorded lessons from your teacher, and possibly participating in virtual elective courses.

### 2) Will virtual days in the Blended model be on a set schedule?

Virtual days within the blended learning model will have a schedule in order for students to participate in their virtual electives. Only a part of the virtual days will include a set schedule. The remaining part of the virtual days will allow for students and families to have some control over "the time, space, place and pace" of learning.

### 3) How will we accommodate the blended model when holidays fall on Monday?

To accommodate the continuance of a 4 day work week when there is a holiday that falls on a day scheduled for students, the work will shift in the week. Instead of attending on Monday and Tuesday or Thursday and Friday, students will attend on Tuesday and Wednesday or Thursday and Friday. The cleaning for the classroom will take place after school hours.

4) Are we able to have two siblings on opposite schedules and not follow the A or B model based on their last names?

Contact the building principal with specific concerns related to A and B cohorts. Accommodations are being made by principals and counselors to adjust schedules and balance enrollment to accommodate requests.

### 5) Will enrollment be balanced in the blended learning model?

Enrollment numbers are being reviewed. Principal leaders and counselors will work to balance enrollment to accommodate siblings and the last names of students enrolled.



## FAQs

## Instructional Model 2 – mySchool Online

1) If teachers are in class instructing students all day, who is responsible for online instruction for the students whose parents choose to keep them home?

Generally, teachers assigned to the mySchool online model will be working solely with students within that model.

### 2) Will students be able to work in groups through Google Hangout?

There are several features that are "in development" with Google. One of these features is Google Meet Breakout Rooms. We will continue to monitor updates to our district G Suite tools and provide teachers with professional development in the use of these tools.

### 3) Will students be logging on with teachers for all 5 days?

With mySchool Online, students will attend school remotely, following the schedule for mySchool Online. This schedule has been developed to provide blocks of instructional times, scheduled breaks and lunch. We are working to determine how best to provide instruction with the specials and elective course teachers. Students work with teachers 4 days, and independently on the fifth day.

## FAQs Specials & Electives

### 1) Will specials be offered?

Elementary specials and Secondary Music subcommittees have shared recommendations for **Virtual Asynchronous Learning.** VAL is SAFER than in-person or synchronous learning due to the guidelines shared at the elementary and secondary reopening meeting.

Equity

- Teachers will have the flexibility to provide more equitable and improved communication than we encountered in the first stay-at-home learning in the spring of 2020. Students who are missing from interactions online can have more direct interventions this school year from a specialist to walk them through what it will look like to interact virtually.
- Teachers are more familiar with the challenges in providing equitable access for families participating in specials classes online, and will plan assignments and assist with participation to create as equitable of a learning environment as possible.



## FAQs Special Education

### 1) What about teachers, staff, or students in behavioral rooms?

Students with disabilities whose IEP least restrictive environment placement is a "Special Class" (self-contained) will receive **in-person** specially designed instruction and services (AU, ED, MD). Staff supporting low-incidence students and low-incidence students will be in attendance when the school is open to all other students regardless of the day of the week. If there is a day when no other students are in attendance, no low-incidence students will be in attendance.

2) Will the District provide classrooms with amplification systems for hearing impaired students to hear their masked teachers?

The services and needs specific to students with disabilities are determined on a case-by-case basis by the student's IEP and or 504 Plan team.

## FAQs Gifted Education

### 1) Will gifted services be offered?

Gifted services will be offered for students in the blended and MySchool online models. Delivery of services is being determined based on parent/family learning model selections. Students participating in either model will receive the appropriate amount of mandated hours.



## FAQs Mask Wearing

### 1) What happens during a mask break?

Students and staff will be at least 6 ft distance from another when taking a mask break.

### 2) Will PPE be provided to staff? (e.g., gloves, masks)

Face shields are being made for each employee. The cleaning and custodial staff will have gloves provided as usual for their work. Other departments will be evaluated for specific needs.

### 3) Will there be a designated person to monitor the compliance of the masks?

No. We will continue to all remind students and staff of the importance of wearing masks. If you have any questions or concerns, you should bring them to the building administrator.

## **Temperature Checks**

We are currently assessing at-home or in school temperature checks based on final numbers of students and staff in our buildings.

At minimum, parents will be required to assess their students every morning before sending them to school.
