WORK SESSION: TOPIC – STUDENT SUPPORT

Superintendent Doug Heuer stated the Board of Education is currently engaging in the adoption of new policies put forth by NEOLA. The series of policies that will be coming up soon are what Mr. Heuer considers the heart and core of the business of the school district:

2000 - Education Program Policies

5000 – Student Rights and Responsibilities

In total, policies are what create the enactment of the district vision. The primary focus of the Board's work is to enact the vision of a high quality educational program of the Cleveland Heights-University Heights District, and policies are the way this is accomplished.

Superintendent Heuer asked the Board when reviewing and adopting policies to consider the question, "Do they result in the vision the Board has for the educational program of the students of the District?" Complicating this process is the fact that included in the Teachers' contractual agreement is Policy 5133 – a student handbook of rights and responsibilities. As such, it creates a situation that is unique to our District, at least in this area of the State. This means in order to be compliant with our contract with the teachers, there has to be an alignment between the policies adopted by the Board of Education in the 5000 series and the statements made in the 5133 handbook.

The purpose of this work session, Superintendent Heuer stated, is for the Board to develop a common vision of what the students rights and responsibilities are. With the common vision in mind, the Board needs to move ahead as policies are provided for review and then make them consistent with the contractual 5133 document.

Administrative team members (Christine Fowler-Mack, Joseph Micheller, and Jeffrey Johnston) gave the Board an overview of current policy benchmarks and discussed the 5133 document as it relates to current policy. Mr. Heuer directed the Board's attention in particular to Page 7 of the 5133 handbook relating to jurisdiction/supervision. School counsel, Attorney John Britton, spoke to the Board about how far the actual legal reach of the Board can be in situations mainly involving electronic devices, media, publications and internet usage.

Attorney Britton encouraged the Board to give careful review and consideration of policies to coordinate with the 5133 handbook to ensure consistency in language, definition and interpretation.

Next steps include the Administrative team providing the Board with a tool showing the language of the proposed policy, language of current policy (if it exists), and the correlation to the 5133 document. The Board will then determine a timeline for reading and adopting policies.

The Board is hopeful to complete the 5000 policy series before January 2010.
