BOARD MEMBERS' REMUNERATION

BE IT RESOLVED, by the Cleveland Heights-University Heights City School District Board of Education that members of the Cleveland Heights-University Heights Board of Education shall be compensated at the maximum rate permitted by law and attendance as set by Ohio Revised Code Section 3313.12, including attendance at Board-approved training programs.

MOTOR VEHICLE AND GENERAL LIABILITY INSURANCE

It was recommended that the Board authorize the furnishing of general liability insurance under a group contract to be purchased in accordance with Section 3313.203 of the Ohio Revised Code. It was also recommended that the Board authorize the furnishing of motor vehicle insurance covering officers, employees and pupils of the School District against liability on account of damage or injury to persons or property, such insurance to be purchased in accordance with Section 3313.201 of the Ohio Revised Code. For 2011, general liability insurance will have a limit of \$1,000,000 per occurrence and \$7,000,000 total aggregate. Motor vehicle insurance will have a combined single limit of \$7,000,000.

INVESTMENT OF FUNDS

The Auditor of Cuyahoga County be and is hereby requested to draw his warrants and the Chief Financial Officer of said County be and is hereby requested to pay to the Cleveland Heights-University Heights Board of Education any money in the County Treasury to the account of the Cleveland Heights-University Heights Board of Education and lawfully applicable to the purpose of the current fiscal year; and

Section 2. The Chief Financial Officer be and hereby is authorized to sign and deliver the appropriate documents to secure such advances, as well as the secondary documents to secure the semiannual settlement with the County Chief Financial Officer during the calendar year 2011.

Section 3. Such authorization shall extend to all advances requested during the calendar year 2011.

Section 4. The Chief Financial Officer of the Board be and hereby is authorized and directed to certify a copy of this Resolution to the County Auditor and the County Chief Financial Officer and make such other certifications, requests and reports to the County Auditor and the County Chief Financial Officer as may be necessary to make this Resolution effective.

Report and Recommendation for the 2011-2012 Cleveland Heights High School Schedule

Superintendent Doug Heuer commented that a key component to achieving an excellent rating in the state of Ohio is what happens at Cleveland Heights High School, a flagship for the District. Assistant Superintendent Jeff Talbert, the five small school principals, and a committee of teachers were charged with putting together a comprehensive plan that would allow the District to move forward to achieve that designation. Details of the recommended organizational plan will be discussed at the January 18, 2011 Board work session. Assistant Superintendent Jeff Talbert provided the Board with an explanation of why we are considering changes to the high school organizational structure, including changes to the high school schedule.

Assistant Superintendent Jeff Talbert stated three areas that need to be addressed if we are to move in the desired direction:

- 1. Significantly reduce the 9th grade retention rate,
- 2. Increase the number of students receiving instruction based on the instructional model of their small school, and
- 3. Increase schedule choice and collaboration.

The committee's proposal to address these issues include:

- 1. Reduce the number of small schools at CHHS from five to four,
- 2. Create a common freshman experience for all ninth grade students, and
- 3. Implement a flexible and alternative schedule.

The Board discussed these recommendations.
