#### **WORK SESSION**

#### **Graded Course of Study Adoption**

Dr. Joseph Micheller, Director of Special Programs/Compliance, and members of Educational Services (Kelly Stukus, Robert Swaggard, Allison Byrd, and Hannah Reid) led the discussion on the first reading of the adoption of revised courses of study. The courses to be updated to align to the common core standards and the revised Ohio content standards are English/Language Arts, Science, Social Studies and Mathematics, as well as a K-12 Technology course of study.

#### **Pilot Elementary Swimming Program**

Director of Athletics Kristin Hughes explained the elementary "Learn to Swim" pilot program. Second grade students from Gearity participated in the program at Heights High for eight 45-minutes lessons. The lessons included basic water safety skills and guidelines. Every student in the program made progress and improved their swimming skills. Ms. Hughes said the pilot was very successful.

#### 2013-2014 Waiver Day Discussion

Dr. Joseph Micheller, Director of Special Programs/Compliance, announced the ODE's decision to exclude election day (November 5) from the allowed waiver days for the district. Dr. Micheller said the district is seeking four waiver days for the 2013-14 school year. He proposes the days be used for OTES training, district-wide technology training and safety/security training, benchmark data review, and have a staggered start at the beginning of the school year. Approval of these days will be presented to the Board in July.
