#### AWARDS/RECOGNITIONS

### **Heights Parent Center - Retiring Director Louisa Oliver**

Board President Nancy Peppler recognized Louisa Oliver, retiring as director of the Heights Parent Center after 11 years of incredible leadership. Heights Parent Center, now known as Family Connections of Northeast Ohio, merged with Family Connections. All existing programs and activities at both Shaker Family Center and Taylor Academy will continue as usual. Ms. Peppler pointed out that throughout Louisa's career at Heights Parent Center, Louisa has shown a real commitment to enriching the lives of children and families in our community. Most significant, Louisa has worked tirelessly to promote early childhood literacy. During her leadership, Heights Parent Center partnered with our District for five years on the comprehensive Even Start Program, a federal program focused on literacy for young children of at-risk families. Ms. Peppler presented Louisa Oliver with a plaque on behalf of the Board to express their appreciation of her hard work and commitment to the betterment of our community.

### Heights Summer Music Camp: Reaching Heights - Patrick Mullen

Patrick Mullen, Executive Director of Reaching Heights, acknowledged Music Director Daniel Heim and Camp Administrator Susie Kaeser and others for their achievement in the 6<sup>th</sup> Annual Heights Summer Music Camp. The camp culminated in a performance at Wiley Middle School on June 26. Campers created a patchwork quilt to be presented to Dan Heim. Mr. Mullen announced that the third Reaching Musical Heights Concert will be held at Severance Hall on April 11, 2011.

#### **Website Redesign Team**

Superintendent Doug Heuer announced the inauguration of our new District website, a project spearheaded by Director of Communications Angie Shaker. The new website focuses more on providing current information about our District, schools and programs in an easily accessible way. Principals and administrative assistants at each building will have the ability to add announcements, news and photos in an instant. Ms. Shaker acknowledged the commitment and efforts of the website redesign team, which included: Mike Beckman, Drew Dallet, Jackie Elfvin, Joy Henderson, Kathy Lawrence, Hannah Reid, Angee Shaker, and Steve Titchenal.

### **Special Recognitions from the Superintendent**

Superintendent Heuer expressed thanks to George Petkac and the union leadership of both Trades and the Custodians/Cleaners. Superintendent Heuer acknowledged the incredible job these groups did on preparing the interior and exterior of our buildings for the start of the school year, particularly considering the age of some of our facilities. George Petkac, Assistant Director of Business Services, acknowledged Brenda Watts – Local 102 President and Kelvin Robinson – Local 617 President. Mr. Petkac gave special recognition to members of the Transportation Department who filled in as summer help and assisted with many projects to prepare our buildings for this school year.

Superintendent Heuer also acknowledged administrative assistants Areda Eddy-Walker and Sondra Clarke for their initiative, hard work and creativity in designing a resource manual for secretaries and support staff in the District. Areda and Sondra presented these manuals at the Secretaries/Support Staff Conference they hosted on August 26. Superintendent Heuer said this resource manual may be used as a model for handbooks to be created for the administrative and teaching staff in the future.

Superintendent Heuer announced that during the 2009-2010 school year three of our buildings made significant improvement on their state report card ratings. Roxboro Elementary was rated effective this year as last year, but was only four students away from being the first of our buildings to reach an excellent rating. Principal Tara Grove thanked her staff, students and parents for their efforts and shared what Roxboro Elementary plans to do to reach the level of excellent. Boulevard Elementary raised its rating from academic watch to continuous improvement. Superintendent Heuer congratulated Mr. Larry Swoope and the Boulevard staff and students for their achievement. Noble Elementary moved from continuous improvement last year to effective on this year's report card. New principal Rachel Coleman spoke on behalf of the staff and students at Noble. Last year, Wiley Middle School was in academic emergency. In an effort to make improvements, Wiley staff members initiated block scheduling in language arts and mathematics. During the 2009-2010 school year, Wiley moved ahead two standards in the state ranking, from academic emergency to continuous improvement, a tremendous accomplishment. Wiley also made adequate yearly progress (AYP) and exceeded the value-added standard for the state. Dr. Octavia Reid, Wiley principal, thanked her staff for their efforts and collaboration and the Wiley students for their achievements.

Several students from Cleveland Heights High School participated in the National Barbershoppers Camp held in Columbus during the summer. Superintendent Heuer attended the camp's culminating event held at the Veterans' Memorial Auditorium where our students were selected to perform. Vocal music director Craig McGaughey shared with the Board some of the plans for the music program and recognized the efforts of the vocal music students. This school year, the musical production "Beauty and the Beast" will be performed November 4-7, 2010 with over 300 elementary, middle and high school students participating.

### SUPERINTENDENT'S REPORT

#### **Update on the RttT Grant – Joseph Micheller**

Dr. Joseph Micheller, Director of Special Programs & Compliance, provided an update to the Board on the recently awarded Raise to the Top (RttT) grant of which Ohio was a recipient. Ohio will receive \$400 million over the next four years in order to implement transformative school reform. Cleveland Heights-University Heights City School District will receive \$1,234,796 over the period of the grant.

Along with RttT, Dr. Micheller reported that another significant grant the District has received is the School Improvement Grant for Bellefaire School. Bellefaire was the only school in our District to receive the grant. This grant will allow us to put in place some dynamic interventions for students in need.

### **Update on the District Building Report Cards – Jeffery Talbert**

Assistant Superintendent Jeff Talbert gave an overview of the most recent state report card for the District. For clarity, Mr. Talbert provided a glossary of commonly used state report card terms. Our District has remained at the Continuous Improvement rating for the past four years. We did attain the value-added standard this year, which means students made one year's growth. We missed AYP due to one subgroup (IEP) in one area (Math).

Mr. Talbert reported that our student attendance rate of 95% is the highest in ten years, and we expect our high school graduation rate to be at least 3% higher than last year.

An area of concern that Mr. Talbert mentioned is that Monticello Middle school remains in Academic Watch for the second year. This qualifies students at Monticello for EdChoice, a voucher program that provides a limited number of state-funded private school scholarships to students attending low-performing public schools. Block scheduling is being implemented at all three middle schools this year in order to increase instructional time.

Our goal, Mr. Talbert stated, is for every building to improve by at least one designation on the 2011 state report card and for our District rating to be Effective.

#### **Update on AVID – Allison Byrd**

Superintendent Doug Heuer invited Allison Byrd, Coordinator of Secondary Curriculum, to update the Board on the AVID (Advancement Via Individual Determination) Program and steps the District is taking to expand this from a pilot program to a District-wide program. A District site team has been reestablished with the goal of sharing ideas and resources, to create opportunities for staff, parents and students to network and learn together, and to identify and remove barriers to student success. Plans include expanding AVID to the middle school level.

### First Reading of Board Policy 8462 Student Abuse and Neglect

Superintendent Heuer acknowledged the first reading of Board Policy 8462 - Student Abuse and Neglect. Dr. Joseph Micheller was present to answer questions from the Board.
